TOWN OF LADYSMITH – WATER CONTRACT

We began negotiations with the Town of Ladysmith over a year ago. The Trustees have put in many, many hours trying to negotiate a contract that has the best possible result for the residents of the Diamond Improvement District. At this time, a contract has not been finalized and we are still negotiating!

The Trustees remain committed that once a contract has been finalized, they will host a General meeting with residents to outline the terms of the new contract. Residents will be given two weeks (14 days) notice of a General meeting.

FAILURE TO PAY YOUR WATER BILL

IF YOU DO NOT PAY YOUR WATERBILL and your account becomes delinquent, the water will be turned off. The only way to have the water flow again is to pay your bill! If a resident takes it upon themselves to turn the water back on THIS IS AN OFFENCE under Bylaw 120, section 28 which states:

28. Every person who disobeys or fails to comply with any provision of this bylaw shall be guilty of an offence and liable on summary conviction to a fine not exceeding Two Thousand dollars (\$2,000.00) or to imprisonment not exceeding sixty days, or both.
