

DIAMOND IMPROVEMENT DISTRICT

BY-LAW NO. 219

A By-Law for Imposing Taxes upon Lands in the District and Provide for Imposing a Percentage Addition to Encourage Prompt Payment Thereof

THE TRUSTEES of the Diamond Improvement District in open meeting assembled ENACT AS FOLLOWS:

1. That for the year 2024 there is hereby levied the following taxes:

GRADE A-1	Tax of \$250.00 on all parcels of land classified into Grade A-1 of the Assessment Roll
GRADE A-2	Tax of \$310.00 on all parcels of land classified into Grade A-2 of the Assessment Roll
GRADE A-3	Tax of \$360.00 on all parcels of land classified into Grade A-3 of the Assessment Roll
GRADE A-4	Tax of \$420.00 on all parcels of land classified into Grade A-4 of the Assessment Roll
GRADE C	Tax of \$250.00 on all parcels of land classified into Grade C of the Assessment Roll
GRADE D	Tax of \$2,100.00 on all parcels of land classified into Grade D of the Assessment Roll

2. The minimum tax payable for any parcel of property in the above-noted Grades A-1, A-2, A-3, A-4, C and D is as follows:

- (a) Grade "A-1" – a minimum tax of \$250.00;
- (b) Grade "A-2" – a minimum tax of \$310.00;
- (c) Grade "A-3" – a minimum tax of \$360.00;
- (d) Grade "A-4" – a minimum tax of \$420.00;
- (e) Grade C – a minimum tax of \$250.00;
- (f) Grade D – a minimum tax of \$2,100.00

3. The aforementioned taxes shall be due and payable on or before July 2, 2024 but any taxes remaining unpaid on July 5th shall have a percentage addition of 10% added thereto.

4. In addition, taxes remaining unpaid on the 1st day of March next following the date upon which the taxes are levied shall bear interest at the rate prescribed

by the Lieutenant-Governor in Council under the *Taxation (Rural Area) Act*, as set out under Section 717 of the *Local Government Act*.


5. This by-law may be cited as the **"TAXATION BY-LAW 2024"**


